

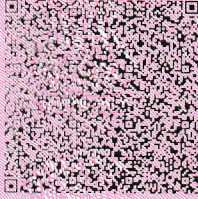

# **MEMORANDUM OF UNDERSTANDING (MOU)**

This Memorandum of Understanding (MoU) is executed on this 12-03-2026

Between **West Guwahati Commerce College**, Pandu: 781012, Assam: as the First Part

And **Pune Institute of Business Management**, Cut no 605/1 Lavasa road. Tal mulshi, Paud road, Pirangut, Pune – 412115, Maharashtra: as the Second Part

**West Guwahati Commerce College** having its campus at Pandu, Guwahati was established in 1992. It stands high with its virtues of excellence and a humble contribution to the society at large in the field of Commerce of not only Assam but the whole of N.E. India as well as other states. It offers a unique educational experience in general education that prepares the next generation of global citizens to lead and make a difference in the world. With its talented, hardworking, motivated student body and accomplished faculty members, **West Guwahati Commerce College** is a leading educational hub in the North-Eastern region that maintains a particular commitment to exceptional undergraduate and post-graduate instruction and aims to be the best College of the region.

**Pune Institute of Business Management (PIBM)** is a leading management institute established in 2007, approved by AICTE, recognised by the Association of Indian Universities (AIU), and affiliated with the Savitribai Phule Pune University (SPPU). We are proud to hold NAAC Grade 'A' accreditation, NBA accreditation, membership with the prestigious AACSB, and are consistently ranked among the Top 125 Institutes in the NIRF Ranking. Our mission is dedicated to bridging the gap between academic knowledge and corporate requirements, ensuring our students are industry-ready.

Whereas **West Guwahati Commerce College** and **Pune Institute of Business Management** have agreed to enter into an agreement at the institutional level with mutual understanding to achieve its objectives, through various students' benefit programmes for academic, technological, sports, socio-cultural promotion considering the scope and challenges of the new National Education Policy 2020 with the following identified but not limited to.

- 1. Faculty support:** Faculty members of both **West Guwahati Commerce College** and **Pune Institute of Business Management** may deliver offline/online lecture(s) as resource persons for portions or special topics of a few identified courses with mutual consultation at a mutually convenient timing. On the day of lecture(s) interactions, the faculty members may be considered to be on duty at the beneficiary institution. Heads of the Institution may mutually alter the dates if such duties of assigned faculty members are seen to hamper important academic or evaluation assignments at his / her place of posting.
- 2. Access to computer lab:** Students will have access to computer lab. However, beneficiary Institution will pay for the basic minimum cost of recurring items if anything is consumed.
- 3. Educational Tour Provision– Pune Institute of Business Management** will organize an Educational Tour for students of **West Guwahati Commerce College**, which will include industry visits, corporate interactions, and selected sightseeing. Travel (to-and-fro)

fare charges from Guwahati to Pune will be borne by the students, all expenses in Pune, including accommodation, food, and local transportation will be taken care of by Pune Institute of Business Management.

4. **Joint organization of Seminars /Symposia / Workshop** - may be jointly organized by **West Guwahati Commerce College**, and **Pune Institute of Business Management**.
5. **Guidance in Career counselling-** **West Guwahati Commerce College** and **Pune Institute of Business Management** will share information on career counselling and opportunities for higher education in India and abroad.
6. **Joint Organization of Placement drive:** **West Guwahati Commerce College** and **Pune Institute of Business Management** will jointly organize Placement drives for the benefit of the outgoing and passed out students.
7. This is a non-binding MoU and there shall be no financial obligation on the part of both **West Guwahati Commerce College** and **Pune Institute of Business Management**.

Both **West Guwahati Commerce College** and **Pune Institute of Business Management** agree that any information which is exchanged pursuant to this Memorandum of Understanding will be kept strictly confidential and used solely for the purpose, covered by this Memorandum of Understanding.

Subject to clause below, both the Institutions may amend this Memorandum of Understanding by mutual consent in writing. Any amendment agreed by the Institutions shall come into effect from the date determined by the signing Colleges on potential areas.

This Memorandum of Understanding shall enter into force on the date of signing and shall initially be valid for a period of three years. Thereafter both **West Guwahati Commerce College** and **Pune Institute of Business Management** shall agree on mutual consent on the continued validity of this Memorandum of Understanding.


In any other circumstance, or other detailed collaboration between the two parties, a separate MOA (Memorandum of Agreement) shall be drawn up as and when required.


This institutions, **West Guwahati Commerce College** and **Pune Institute of Business Management**, agree that this Memorandum of Understanding shall enter into force on the basis of goodwill and shall not be legally bound. Nothing mentioned in this Memorandum of Understanding shall deem constitute partnership between the signing institutions appointing one party as an agent of the other.

This Memorandum of Understanding will be effective upon signature by both the Head of Institutions for a period of three years, at which time it will be reviewed for possible renewal for further three years period. Either party may, on three (3) months' notice in writing, terminate the MoU in advance of its normal expiration or request the recognition of its conditions.
